	<ul> <li>Requests for changes to the Land Use Bylaw;</li> <li>Request that council clarify whether the 6 person limitation on tourist homes applies to the home or the entire property. For example could a tenant in a tourist home could bring an RV on to the property when they are renting it, therefore having more than the 6 people allowed.</li> <li>Requested that measurements in feet and meters be added everywhere as they are currently only in some places.</li> <li>Provide clarity on the age of manufactured homes. Make it clearer that they do not have to be removed once they are past a certain age.</li> <li>Opinion that some of the information in Parking Section on recreational public/private outdoor parking could be eliminated as unnecessary.</li> <li>Clarity on how many RV's are allowed on a property and clarity on whether this includes motorhomes.</li> </ul>
